

API License Agreement Kyiv

This API License Agreement (hereinafter referred to as the "License") shall define the rules for the Licensee's use and access to the API of Nova Poshta LLC (hereinafter referred to as the "API"), as well as data and documentation provided by Nova Poshta Limited Liability Company (hereinafter referred to as the "Licensor"). By using the API, the Licensee shall comply with the terms of the License. Otherwise, the Licensee shall not be allowed to use the API.

The API is protected by Ukrainian copyright laws and regulations and international copyright treaties ratified by the Verkhovna Rada of Ukraine.

1. DEFINITIONS OF TERMS

- 1.1. **API** means a set of libraries, tools, source code samples, published specifications and documentation, the exclusive intellectual property rights to which belong to the Licensor. In addition, the Licensor may, at its sole discretion, provide the Licensee with updates or additions to the API.
- 1.2. **The Licensor** means NOVA POSHTA Limited Liability Company, represented by Director Oleksandr Mykolaiovych Bulba, acting under the Charter.
- 1.3. The Licensee means an individual or legal entity(ies) using the API rights under this License.

2. SUBJECT MATTER OF THE AGREEMENT

- 2.1. Under the terms of this License, the Licensor shall grant the Licensee a non-exclusive, revocable, and free license (without the right to sublicense) to use the API for the sole purpose of automating the services provided by NOVA POSHTA LLC (USREOU code 31316718).
- 2.2. The territory covered by the License: The territory of Ukraine where services are provided under the NOVA POSHTA trademark.
- 2.3. **License validity period:** The license shall be valid for the entire term of the intellectual property rights. However, if the Licensee fails to comply with the terms of this License, the rights granted under this License shall automatically be terminated.
- 2.4. The terms of using the API are inseparable from the Terms of Service of NOVA POSHTA LLC, which are available at https://novaposhta.ua/ and the Rules for using the Personal Account, Mobile Application, and Application Program Interface, which are available at https://devcenter.novaposhta.ua/. The text of this License is available at https://devcenter.novaposhta.ua/.

3. RIGHTS OF THE PARTIES

- 3.1. The Licensee shall be entitled to use the API for the sole purpose of automating the services provided by NOVA POSHTA LLC (USREOU code 31316718).
- Reproduction of source code. The Licensee shall not have the right to the API source code, except for the rights explicitly granted to the Licensee under this License. The Licensee shall not be entitled to copy, sublicense, make reverse engineer or reverse design, decompile, disassemble, modify, or alter any part of the API; use the API for other purposes on behalf of a third party; allow other services to disable, fix, or
- 3.3. For effective use of the API, you may need additional software (hereinafter referred to as "Third Party Software"). The Licensee shall be solely responsible for the acquisition of this software and the necessary licenses. The Licensor shall not be liable for any obligations and shall not provide any guarantees for the use of the Third Party Software by the Licensee.

otherwise interfere with any mailings, notifications to end users, or consent forms intended for the user provided by the API.

- 3.4. The Licensee shall not be allowed to use the Licensor's trademarks or brand names, except for the terms specified in clause 2.1. of the License.

 The Licensor shall reserve all rights not expressly granted under this License.
- 3.5. The Licensee shall not be entitled to obtain copyrights to the API or applications developed with the API or the APIs of other API licensees to create, use, or sell any products or technologies.
- 3.6. The Licensor shall reserve the absolute right to limit the number and/or frequency of API requests at its sole discretion.



3.7. The Licensor shall reserve the right to amend this License at its sole discretion at any time by posting the text of the new version of the License on the website https://devcenter.novaposhta.ua/. The Licensee shall keep itself informed of such changes from time to time. The amendments shall become effective upon posting the revision on the website https://devcenter.novaposhta.ua/, and the Licensee's continued use of the API after any such posting shall imply its acceptance of the amended terms of the License.

4. INTELLECTUAL PROPERTY RIGHTS

4.1. All intellectual property rights, including copyrights, commercial secrets, trademarks for goods and services, as well as amendments or updates to the API under whatever conditions, shall be owned by the Licensor.

Reproduction of source code. The Licensee shall not have the right to the API source code, except for the rights explicitly granted.

4.2. The Licensee shall be entitled to use the API exclusively under the terms of this License.

5 WARRANTIES

- 5.1. The API and documentation are provided as is without warranty of any kind. The Licensor shall not warrant that the API and documentation are suitable for use by the Licensee or are free from defects or errors. Moreover, the Licensor shall not warrant continuous uninterrupted access to the API and documentation and shall not provide any guarantees as to the results of their use.
- 5.2. The Licensee shall be solely liable for any damage to its computer system or loss of data resulting from the use of the API. The Licensor shall not be liable for any special, incidental, or indirect damages (including, but not limited to, lost profits, business interruption or suspension, computer failure or breakdown, loss of information, or any other damages, including financial losses, arising from the use or inability to use the API or the provision or failure to provide support services), even if the Licensor has been advised of the possibility of such damages.

6. LIABILITY

- 6.1. If the Licensee fails to comply with any term of the License, this shall result in the Licensee being liable to the Licensor for any damage or losses caused by the violation of the terms.
- 6.2. The Licensee shall be administratively, civilly, and criminally liable for violation of the terms of the Licensor's intellectual property rights.
- 6.3. If the Licensee violates the terms of this License, including, but not limited to, copying, partial copying, sublicensing, code analysis, reverse engineering or decompiling, disassembling, modifying, or amending any part of the API; using the API for other purposes on behalf of a third party; allowing other services to disable, fix, or otherwise interfere with any mailings, notifications to end users, or consent forms intended for the user provided by the API, as well as any other actions that prove violation of the Licensor's intellectual property rights, the Licensee shall, at the Licensor's request, pay the latter a fine of 200,000.00 (two hundred thousand) hryvnias for each case of violation.
- 6.4. Paying a fine shall not relieve the Licensee from liability to compensate for the actual damages caused and to stop the unlawful use of the API.
- 6.5. Any violation of the terms of this License shall result in its termination. Terminating the License shall not relieve the Licensee of the liability to compensate the Licensor for the damages caused by the violation and to pay penalties.

7. VALIDITY PERIOD

- 7.1. This License shall be valid for the period of validity of the property rights until revoked.
- 7.2. Any violation of the terms of this License shall result in its termination.
- 7.3. Upon cancellation/termination of this License, the Licensee shall immediately stop using the API and destroy all copies of the API and documentation.
- 7.4. The Licensor shall be entitled to verify the Licensee's compliance with the terms of this License. At the Licensor's request, the Licensee shall facilitate this process.

8. OTHER TERMS AND CONDITIONS

- 8.1. The Licensor shall be entitled to suspend (or terminate) the Licensee's access to the API at its sole discretion, without notice or giving any reason.
- 8.2. By installing, downloading, or otherwise using the API, the Licensee shall confirm having read, understood, and agreed to the terms of the License.
